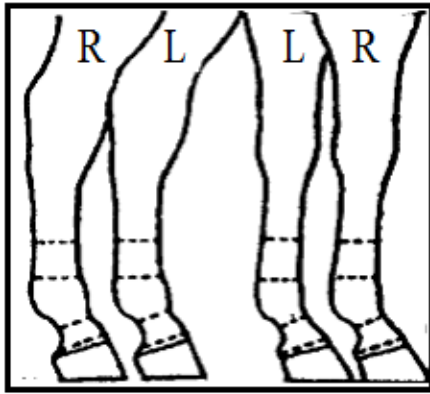

LEFTSIDE

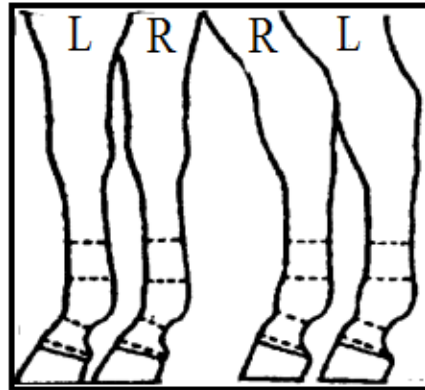
